Accident protection plans are built to provide a financial cushion for unforeseen costs following an unexpected injury. When you submit an eligible claim, the UnitedHealthcare Accident Protection Plan pays a cash benefit directly to you, in addition to the benefits provided by your health plan. You don't have to meet a deductible to receive this benefit. The date of accidental injury must occur on or after the coverage effective date.

Here are some of the injuries and services that may qualify for a benefit payment:

- Ambulance services
- Burns
- Concussions
- Emergency room and urgent care visits
- Follow-up doctor visits
- Fractures/dislocations
- Hospital admissions and stays
- Lacerations (cuts)
- Lodging, travel and child care
- Medical appliances (e.g., crutches, wheelchair, walker)
- Organized sports injuries

This policy covers more than 80 injuries and services. For a complete list of covered benefits, see your Certificate of Coverage provided by your employer.



Family coverage for common sports injuries

The **organized sporting activity benefit** increases the amount payable by 25% if the insured sustains an injury while participating in an organized sporting event:

- Increases benefits for the common injury and follow-up care benefit categories only; please refer to your certificate for specifics
- Payable for all insureds, not just children



Ways to file a claim

When it comes to processing your claim, you have options.



Claims portal: Log in to myuhcftp.com to submit a claim. You can also set up direct deposit and view claims status and payment history.



Phone: Call us toll-free at **1-866-556-8298**. Hours of operation are Monday–Friday, 8 a.m.–8 p.m. ET. If we receive the required data from your employer, we can initiate the claim over the phone. Your human resources (HR) team can confirm for you.



Hard copy claim form: Request the claim form from your HR representative. Complete, sign, date and send the form via fax or mail to the contact details listed on the claim form. You may also email the completed form to fpcustomersupport@uhc.com. Please note, this is an unsecured email address.



Benefit Assist: Benefit Assist is a program designed to proactively identify eligible supplemental health claims. When a qualifying claim is identified, you're either paid automatically or contacted by a claims specialist* to help you get the benefits you're eligible for. Confirm with your HR team if this option is part of your policy.

Help maintain your health with a wellness benefit

Some accident protection plans include a wellness benefit that's built to help you maintain or improve your health by helping pay for certain preventive care screenings like cancer screenings, colonoscopies and blood work.

Please check your Certificate of Coverage to see if the wellness benefit is included in your policy.** Here are some of the conditions and services that may qualify for a benefit payment:

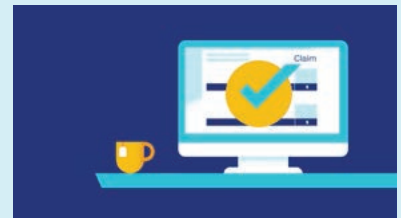
- Blood tests for certain cancers
- Blood test for triglycerides
- Bone marrow testing
- Breast ultrasound
- Chest X-ray
- Colonoscopy
- Fasting blood glucose test
- Flexible sigmoidoscopy
- Hemoccult stool analysis
- Mammography
- Pap smear
- Serum cholesterol test
- Stress test on a bicycle or treadmill
- Thermography
- Virtual colonoscopy

The wellness benefit is payable one time per calendar year.
